(2) All evening softball field reservation requests for the Pine's Recreation softball field will require advance payment of \$25.00 per requested date that field lights will be used, check made payable to "Town of Groveland" and is non-refundable if field use is cancelled due to rain or other circumstance. Fees for all adult league (non-youth recreation sponsored) field usage will require advance payment of \$25.00 per team, per game, plus field light charge if evening games.

(3) USE OF ALCOHOLIC BEVERAGES OF ANY KIND IS PROHIBITED AT ALL TOWN FIELDS AND OTHER PUBLIC PROPERTY AND WILL BE STRICTLY ENFORCED. PERMITS WILL BE SUSPENDED INDEFINITELY IF A VIOLATION OCCURS. IT IS THE RESPONSIBILITY OF THE PERMIT HOLDER TO NOTIFY ALL TEAM PLAYERS, COACHES, & SPECTATORS OF GAMES.

(4) Please instruct all players, coaches and visitors to drive carefully and no faster than 5 mph when entering and leaving town facilities; remove all trash and water bottles from the dugouts when leaving the field; last team off field puts bases in the orange box; and removable pitchers' mound and 4 nails to be put in orange box if it is removed from the field.
